Your Retirement Benefits

The AB 197 state legislature will end the inclusion of terminal pay in the final calculation for retirement. We will no longer be able to calculate up to a years' worth of earned vacation into our retirement. On November 28, 2012, the Superior Court in Contra Costa County ordered a stay on implementation of AB 197 in this county. The stay is effective for 60 days.

In the meantime, the PPOACCC filed an injunction to stop these changes from taking effect. Our attorneys, along with many of the 15 other bargaining units in Contra Costa County, will be participating in a lawsuit against the CCC Retirement Board for, what we feel, is an incorrect application of the law. The PPOACCC is confident our vested rights will be preserved.

The good news and the bad news: The good news is, with the injunction in place employees are not forced to make a hasty decision in regard to when they need to retire. The PPOACCC will continue to do everything in their power to affect a beneficial outcome for its members, however, (this is the bad news) the final decision is ultimately in the hands of the court. Upon any change to the injunction, or any court rulings, members will be notified via email. If you are not currently receiving association emails, please submit your email address to Rich Berkery so you can stay informed on these important changes.

Long term disability benefits are available to all PPOACCC members through the California Law Enforcement Association (CLEA). The plan is offered at only \$24.50 per month! Should you become ill, have an accident, on or off the job, or need time off due to pregnancy, the plan will pay you up to 80% of your wage after a leave of 60 days. It also offers a death benefit to surviving family of plan subscribers. To enroll, all you have to do, is complete a very short application and submit it to Cindy Neiman at the Martinez Office, or payroll manager at your worksite, and your done!
